Exploring sexual assault from a legal angle is new and powerful—especially in the post-Brock Turner era. **The Nuts and Bolts of Responding
to Federal Investigation on Campus**

In recent years, the media has paid increasing attention to the U.S. Department of Education's Office for Civil Rights (OCR) process when investigating sexual misconduct cases. However, this media attention does not tell the whole story. While many Title IX cases are investigated broadly by OCR across campuses (e.g., the collection of three years-worth of case files, extensive federal presence on campus), there are certain cases where OCR has recently begun taking a more focused approach. Moreover, even though they are both part of the U.S. Department of Education, OCR's approach with Title IX is different from Federal Student Aid's approach to investigating Clery Act violations, for example. Adding further to the challenge, if your institution receives federal funding through a U.S. Department of Justice (DOJ) grant, it may also be susceptible to a DOJ program review, which also looks and feels different.

Relying on nearly a decade of experience working as an attorney at OCR, and his current role defending over two dozen institutions in federal reviews, Mr. Catanzano will start by sharing some fundamental tips to respond to federal inquiries both in the traditional Title IX context and beyond. He will discuss the different approach taken by the Trump administration thus far, both in OCR and the DOJ. Finally, he will provide the participants with concrete tips to allow them to begin acting and organizing now to better respond to any federal inquiries, with the goal of hopefully avoiding them entirely.
